

Note from the Editor-in-Chief

Dear readers,

as of this issue, we introduce a (partly) new editorial team, as Cato Wittusen and Oskari Kuusela are replaced by Sorin Bangu (Bergen) and Lassi Jakola (Helsinki). I want to thank Oskari and Cato for their work during the past few years, and welcome Lassi and Sorin to the journal's editorial staff. We also have a new editorial assistant, Filippo Mosca (Rome). The other members of the editorial team continue: Gisela Bengtsson as article section editor, Alois Pichler as from the archives section editor, Jasmin Trächtler as book review editor, and Simo Säätelä as editor-in-chief.

Our publishing model is based on continuous submission and publication and has proved to work quite well. One advantage with the continuous publication model is that it facilitates our open review process: Submissions are, as soon as they have gone through anonymous peer review and been accepted for publication, released online for open review for four weeks. During this time readers can submit comments and remarks on the paper, and the author has the option of revising the paper in the light of these comments. The aim is to promote a collaborative scholarly effort that can enhance the quality of the contributions. Indeed, several of our authors have received valuable comments during this process. We have now introduced a dedicated email address for open review comments, which we hope will further facilitate the open review:

Comments sent to this address will be read by the editors and forwarded to the author. For further open review instructions, consult the text below.

The continuous publication model also means that we no longer have specific deadlines for submissions. Instead, received submissions are processed continuously, and submissions that are accepted after peer review are released online with as little delay as possible. If you have further

Prepublication Open Review Information Volume 13 (2024)

NWR has implemented a continuous submission/publication model. Most articles published will be open for comments for four weeks in PREPUBLICATION OPEN REVIEW.

We invite comments and discussions on these articles. Our hope is to engage the community in a process of collaborative review, with the aim of enhancing the scholarly value of the contributions. All kinds of comments, from pointing out typos to more wide-ranging commentaries, are welcome as long as they are constructive and help the author improve the text. Extensive comments or discussions can, if relevant, be considered for publication in our Comments section.

After the four-week open review period, the author has the opportunity to revise the preprint version of the submission before publication of the final version.

How to participate in open review?

You can comment on an article by sending a mail to OpenReview_comments@nordicwittgensteinreview.com. Comments will be read by the editors and then forwarded to the author. Commentators are expected to appear as peers, i.e. by their real names. If you have reasons to want to retain anonymity in relation to the author, please contact the editor-in-chief.

OPEN REVIEW GUIDELINES

1. In your comment, please refer by article name and page number, or by quoting the passage you comment.
2. We seek constructive commentary and criticism that may help the author improve the text.
3. Use the dedicated email address to send in your comments.
4. Please note that Prepublication versions of articles are works in progress. Remember that the final version will be published after the four-week Open Review period. If you nevertheless need to refer to an article currently in Open Review, use the following format:
