

Editorial Note

This is the fourth *Nordic Wittgenstein Review* Special Issue. It is edited by Salla Salskov Aldrin and Hugo Strandberg and dedicated to *Moral Understanding*.

The impulse for this issue goes back to a conference in honour of Lars Hertzberg's 80th birthday in 2023, organized by the issue's guest editors. The theme of the issue, moral understanding, is a notion centrally connected to moral philosophy in a certain Wittgensteinian tradition, and especially to Hertzberg's work. As Lars is a former editor of the NWR and has, even after his retirement, been an untiring source of support for the journal — for instance as a member of its editorial board and as a dependable reviewer — this special issue is a fitting way to draw attention to his work in philosophy and to highlight his importance for Wittgensteinian philosophy, especially in the Nordic countries. I would like, on behalf of the journal, to offer him my heartfelt, though belated, congratulations.

On NWR Special Issues

The three earlier NWR Special Issues are:

- “Wittgenstein and Forms of Life”, edited by Danièle Moyal-Sharrock and Piergiorgio Donatelli, published in November 2015.
- “Post-Truth”, edited by Rupert Read and Timur Uçan, published in July 2019.
- “Wittgenstein and Feminism”, edited by Sandra Laugier, Mickaëlle Prevost, and Jasmin Trächtler, published in December 2022.

NWR welcomes proposals for further guest edited special issues, which present an opportunity to explore a topic from diverse perspectives in one issue of the journal. There is no fixed deadline for submission of proposals, but Special Issues occur at most once

every 1–2 years. Scholars interested in guest editing an issue are welcome to contact the editor-in-chief for details. Decisions about publication are made by the editorial board.

The current Special Issue is first published for a four-week open review period. This means that we invite comments and discussions on its articles. Our hope is to engage the community in a process of collaborative review, with the aim of enhancing the scholarly value of the contributions. After the four-week open review period, the authors have an opportunity to revise the preprint version of their submission.

To comment on an article, please send a mail to the address below. Commentators are expected to appear as peers, i.e. by their real names.

OPEN REVIEW GUIDELINES

1. In your comment, please refer by article name and page number, or by quoting the passage you comment.
2. We seek constructive commentary and criticism that may help the author improve the text. The discussion is moderated by the editors. Send your comment to openreviewcomments@nordicwittgensteinreview.com
3. Please note that Prepublication versions of articles are works in progress. Remember that the final version will be published after the four-week open review period. If you nevertheless need to refer to an article in open review, use the following format:
